# COMMITMENTS OF THE ETHYPHARM GROUP AND SERVICE PROVIDERS

- Develop responsible and sustainable trade relationships based on consultation with suppliers with the aim of establishing mutually beneficial relationships.
- Reduce risks in the areas of human rights, working conditions, the environment, anti-corruption and business ethics.

## THE ETHYPHARM GROUP ENCOURAGES ITS SUPPLIERS AND SERVICE PROVIDERS TO RESPECT ITS COMMITMENTS:

The fundamental rights of women and men:

- I Ensure a policy of management of employee safety based on continuous improvement.
- Do not accept any discrimination.
- Value, recognize and develop the skills of employees.
- Contribute to the effective abolition of child labour and the elimination of all forms of forced labour.
- Fight harassment in all its forms.

The rules relating to the protection of the environment and contribute to preventing, mitigating and repairing the negative impacts of its activity:

- Optimise water and energy consumption.
- Offer ever more effective environmental solutions.
- Preserve biodiversity and manage waste and discharges.
- Reduce and/or treat its emissions into the air, its effluents into the ground and/or water and pollution of any kind resulting from its activities.
- Seek eco-design solutions to reduce the impacts of the life cycle.
- Give priority to the territorial anchorage and local development.

Ethical principles and contribute to the fight against corruption, influence peddling and conflicts of interest in its activities and relations with its suppliers:

- Promote free competition, thus outlawing any consultation and agreement on prices and offers, excluding participation in any cartel.
- Comply with all national and international standards on economic offences, particularly those relating to the financing of terrorism, money laundering, embargoes, arms and drugs trafficking.
